Mouth* Itching, tingling, or swelling of lips, tongue, mouth

Epinephrine Antihistamine

Skin: Hives, itchy rash, swelling of the face or extremities

Epinephrine Antihistamine

Gut: Nausea, abdominal cramps, vomiting, diarrhea

Epinephrine Antihistamine

Throat*: Tightening of throat, hoarseness, hacking cough

Lung*: Shortness of breath, repetitive coughing, wheezing

Heart*: Thready pulse, low blood pressure, fainting, pale, blueness
